- The President presides at all meetings of the Board and ensures that orders and resolutions of the Board are carried out.

- The Treasurer acts in the President's absence and receives, deposits and disburses all funds of the Association. The Treasurer keeps records of accounts including an annual budget and balance sheet statement and initiates an annual audit of the Association books each fiscal year.
